### State of Arkansas Continuation of Coverage Election Form

The State of Arkansas Continuation Law (A.C.A. §23-86-114) allows a Covered Person to extend their Group Health Insurance Policy coverage for up to one hundred twenty (120) days. In order to be eligible for this option, the Covered Person must have been continuously covered under the Group Health Insurance Policy for at least three (3) consecutive months prior to employment termination or change in dependency status and must make the election by notifying the Company (Arkansas Blue Cross and Blue Shield or Health Advantage) no later than 10 days after employment termination or change in dependency status. The Group Health Insurance Policy premium must be paid in full by the Covered Person to the Group (Policyholder) by the date specified below. Failure to pay this premium will result in cancellation of coverage for the employee and/or any dependents on such Group Policy.

- The date on which the Covered Person is covered for similar benefits under another group or individual policy;
- The date on which the Covered Person is eligible for similar benefits under another group plan whether insured or uninsured;
- The date on which similar benefits are provided for, or available to the Covered Person under any state or federal law;
- The date on which the Group Policy terminates.
